Copies of the Gold Award Certificate should be printed for display on the Town Council noticeboards.

ii. Fundraising suggestions:

- Local plant nurseries and businesses should continue to be contacted with requests for specific projects, rather than for St Ives in Bloom generally;
- Both gardening and fundraising connections should be developed with diverse communities for different areas of the cemeteries:
- After agreement is reached with the Town Council on the details of the Ramsey Road cemetery project, funeral directors should be approached for sponsorship at the cemetery.

b) Social media and the website:

There was some discussion about the presentation of the website and of the St Ives in Bloom facebook page.

c) Berman Park:

Robin introduced the topic of Berman Park, and our plans to work with HDC and other community groups on improvements to the area, following a meeting we had with HDC in May 2021. Hattie explained that she and Phil had also attended a discussion day in September 2022, where Berman Park was identified as a priority project. However, HDC has not yet fully taken over the management of the park, Margaret will investigate. (The day after the meeting, Margaret received confirmation from Judith Arnold that Berman Park "will be managed by HDC when it is handed over from the developer".)

In the meantime various plans and ideas were suggested, including:

- the St Ives Eco-faith group have already pinpointed an area where they would like to construct a Peace Garden;
- both Robin and Hattie are interested in involving the schools, and have raised this possibility at both the meetings with HDC;
- involvement of the local residents group;
- creation of a "Friends of Berman Park" group;
- daffodil planting at the top of the slope;
- · provision of better and more benches.

All volunteers were asked to go on a walk round Berman Park in the next couple of weeks and to email Hattie any ideas and suggestions for its management or improvement, for discussion at the next Committee meeting. The committee can then respond to the consultation process on behalf of St Ives in Bloom.

Section A. Horticultural Achievement.

There is lots of colourful planting on display, with efforts made to have all year-round interest. All the displays were well maintained with healthy plants and a good mix of perennials and annuals. Many of the town businesses had floral displays, which made the areas very attractive.

*Areas of Achievement:

- The Waits riverside display was a colourful display of planting, and a good mix of varieties there was also wonderful knitting (Yarn Bombing) display on all of the railings.





SAFEGUARDING Policy for St Ives in Bloom October 2021

The Committee and volunteers of St Ives in Bloom have limited contact with children or vulnerable adults. This would mainly be within a group context and/or in a public space, taking part in activities with minimal physical contact, and never left alone or unsupervised.

The responsible person for Safeguarding Children and Adults at Risk is the Secretary. Volunteers should approach her regarding any concerns for an individual, and she will take responsibility to ensure that appropriate bodies are informed, should this be required.

When work parties are planned in a setting where either vulnerable adults or children may be present on a regular basis (e.g. a care home or a school), then further advice and training would be sought from the participating setting. Staff at the school or care home would always be present along with the volunteers. The responsible person will monitor contact with children or adults at risk to ensure that the frequency and intensity of contact is consistent with the DBS threshold levels; and volunteers may be required to undertake a DBS check. (The primary role of the Disclosure and Barring Service (DBS) is to prevent unsuitable people from working with vulnerable groups including children.)

Health and Safety Policy for St Ives in Bloom

October 2021 (*amendment to nominated Committee member, 31 Jan 2023)

Introduction

The St Ives in Bloom Committee has overall responsibility for health and safety in the organisation, and for ensuring that it fulfils all its legal responsibilities. It recognises that it is the duty of committee members and volunteers to uphold this policy and to provide the necessary funds and resources to put it into practice. The St Ives in Bloom Committee is committed to ensuring that all its activities are safe, and it will do whatever it can to provide for the health, safety and welfare of all volunteers and passing members of the public, ensuring that risks are minimised at all times. It will observe the Health and Safety at Work Act 1974 ("HASAWA") and all relevant regulations and codes of practice made under it.

This policy will be reviewed annually by the management committee.

1. The St Ives in Bloom Committee Responsibilities

The Secretary is responsible for the implementation and monitoring of health and safety policies and recommending changes where necessary. All accidents or unsafe incidents will be investigated by the *nominated Committee member (Phil Davies, 2022 – 23) on behalf of the Committee as soon as possible and then be reported to the Committee at the next available meeting.

The Committee is responsible for:

- Assessing the risk to the health and safety of volunteers and passing members of the public at working party locations, and identifying what measures are needed to comply with its health and safety obligations;
- Ensuring that locations are safe and without risk to health;
- Ensuring that any St Ives in Bloom owned equipment is well maintained;
- Ensuring that St Ives in Bloom activities are covered by insurance (at present RHS 'In Bloom' insurance policy of up to £5 million public liability);
- Providing information to volunteers as to safe working methods and procedures as required;
- Encouraging volunteers and members to co-operate in ensuring safe and healthy conditions and systems by effective joint consultation;
- Establishing emergency procedures as required, including:
 - a) the work party leader having a mobile phone with them;
 - the work party leader providing drinking water and encouraging rest periods on hot days;
 - making sure there are toilets and washing facilities nearby where working parties/activities are over 2 hours long.

2. Volunteer Responsibilities

All St Ives in Bloom volunteers will ensure that:

- They are aware of the contents of this safety policy;
- They comply with this policy;

- They make sure that the gardening equipment that they bring from home is safe to use, and that they are fit to use it;
- They take care of themselves and others who may be affected by their actions or omissions;
- They will report all accidents, or unsafe situations, and any near misses (things which could have led to an accident), to the Secretary or other committee member at once:
- If they identify anything which they think could be in any way unsafe, they will report it.

3. Risk Assessments

The Secretary will ensure that all working party locations and tasks are assessed. Assessments will be repeated when there is any reason which makes the original assessment not valid (e.g. change of tasks or change of volunteer group).

4. Training

To promote the health, safety and welfare of volunteers, health and safety reminders will be provided as follows:

- · during the volunteers' first session,
- · when changes are made to work party locations,
- when training needs are identified during risk assessments.

5. Resolving health and safety problems

Any volunteer with a health and safety concern must first tell the Secretary. If, after investigation, the problem is not corrected in a reasonable time, or the responsible committee member decides that no action is required but the volunteer is not satisfied with this, the volunteer may then refer the matter to the St Ives in Bloom Committee Chairperson. This must be in writing. If the volunteer is still dissatisfied, the matter will be entered on the agenda for the next meeting of the Management Committee.

Addendum to St Ives in Bloom Grant Application 2024

Since the grant application to the Town Council was submitted, the results for Anglia in Bloom have been announced and St Ives won Gold for 2023. Following this, the Anglia in Bloom Judges have selected St Ives to represent Anglia in the national 60th Anniversary, RHS, Britain in Bloom competition in the category of large town. St Ives will be competing with the best large towns from each of 16 regions across Britain. This is a wonderful opportunity to showcase St Ives and everything it has to offer.

The theme of Britain in Bloom this year is friendship. So, this will mean the engagement with the community and everything that St Ives in Bloom does with its volunteers will have a great impact. "In Bloom" is not just about horticultural merit, it includes community engagement and strongly supports improving the environment. It is about making St Ives a place that people want to visit and where everyone wants to share experiences and time together. However, we very much want to compete strongly in the final of the competition and for this it is important that the feedback from 2023 is taken on board. In most cases it means doing what we did in 2023 to a higher standard of excellence. Several areas such as The Waits with its excellent and diverse planting and the Holt island reserve were commented on very favourably. The new garden at Ramsey Road cemetery will be showcased as a large project and the Italian garden there also. Both will need significant further sustainable planting. We also want to continue to maintain and improve sites like the area next to Kings Hedges, the Postbox garden and Station road area in the town to an even higher standard than this year. The Britain in Bloom judging will be in summer 2024 and we want to town to be at its best from June into August. I will certainly share the dates as soon as I have them.

Our volunteers will provide over 5000 hours of expert work around the various sites we manage in the town. There are also many generous donations of plant from our team and others around St Ives. Furthermore, we are already planning to engage with other groups in the town and making plans to use everyone's skills to ensure we are successful. To do this it is more than ever important that we receive the assistance of the Town Council, both in terms of assistance from the team, working with them to ensure success, but also to receive the full grant from the Town Council that enables us to fund the planting we need to do across the whole of St Ives.
